The Home Education Program applies only to students ages six through sixteen. The parent/guardian who assumes responsibility for educating a child at home also has the responsibility for providing

Parents have the freedom to determine their child's educational path and the plan for reaching their goals. This notification is only good for the current school year. Home education is defined by FS as "sequentially progressive instruction of a student by his/her parent or guardian in order to satisfy school attendance requirements." Please review the legal responsibilities and obligations carefully prior to enrolling your child into home education. Home Schooling. In Ohio, parents interested in educating their children at home may do so by notifying their local school district superintendents and meeting the requirements of Ohio law to home school. Homeschooling is a form of education where the parent or guardian is the instructor. The reason for this form of education is usually the guardian is not happy with the nearby schools, or sometimes for religious or moral purposes. Home education in the UK is often termed "elective home education" (EHE) to signify the independent nature of practice from state provisions such as education for children with ill-health provided by the local authority in the family home. Home Education is one of five legal ways to satisfy the compulsory attendance law. Florida Statute 1002.41 gives parents the choice of achieving regular school attendance through ONE of the following provisions; a public school, a parochial, religious, or denominational school, a private school, a home education program, a private tutor program.
